General Information

Eligibility

All participants must be at least 45 years of age on or before December 31, 2010. There is no upper age limit. Proof of age may be required at event check-in.

Age Divisions

Age divisions for all events are in five-year age groups except where noted: 45-49, 50-54, 55-59, 60-64, etc. A participant's competition age will be based on her age as of December 31, 2010. The age division for all team competition will be determined by the age of the youngest player as of December 31, 2010. The right is reserved by the Detroit Senior Olympic Games to combine age groups in any event due to insufficient entries or other conditions.

Team Registration

Mail your completed team roster form, and team waiver with a check/money order. Prior to competition, all team athletes **MUST HAVE SIGNED** the team waiver form, or the team will not be eligible to participate.

Registration Deadline

The early bird registration deadline is March 31, 2010. On April 1, 2010, an addition \$35 fee will be charged per team. The final registration deadline is Thursday, April 30, 2010. Team entries from Team Captains are also due by these dates. Entries postmarked after the 4/30/10 deadline may be accepted if space is available. Registration will not be processed until all fees are paid and the liability waiver is signed and dated. No registrations or entries will be accepted on the day of events and/or games.

Medals

Gold, Silver and Bronze medals will be awarded in all divisions within each age group at the final competition. Any medals not picket up at these times will be given to the team Captain after the games. **NO MEDALS WILL BE MAILED.**

Equipment

Participants are required to provide their own practice equipment. Balls will be provided for tournament Games. Please be sure to mark your personal items and do not leave valuables unattended. The Detroit Olympics is not responsible for the loss or damage of any athlete's personal equipment.

Sportsmanship/Conduct

Unsportsmanlike or disorderly conduct on the part of competitors or coaches will be grounds for immediate removal and disqualification from competition without refund of fees paid. The Detroit Olympics staff reserves the right to disqualify any competitor.

Medical Assistance

Athletic Trainers will be available in case of injury.

Refund Policy

No refund will be made if an entrant fails to compete for whatever reason including medical injury or event cancellation due to inclement weather, war, or an act of GOD.

Refunds of entry fees may occur for:

1. Entries received after the maximum number of entries has been accepted.
2. Insufficient entries in an age division or sport causing cancellation of the division or sport.
3. Entries of non-qualified participants.

Housing and Transportation
